

CLARIDON TOWNSHIP CEMETERY REGULATIONS

- *FLOWER BEDS ARE PERMITTED ON THE **GRAVE SIDE** OF THE STONE ONLY
- *THE FLOWER BED CANNOT EXCEED 12" FROM THE STONE
- *ONLY ANNUAL FLOWERS SHOULD BE PLANTED PERENNIALS WILL BE TREATED AS ANNUALS
- *FLOWER BEDS INTERFERING WITH MOWING, OR UNKEPT, WILL BE REMOVED
- *STATUETES, AND OTHER REMEMBRANCES MUST BE PLACED IN THE FLOWER BEDS
- *NO ROCKS, STONES, OR ANY TYPE OF BOARDERS
- *NO WROUGHT IRON, SHEPARDS HOOKS, OR OTHER OVERHEAD HANGING FLOWER HOLDERS
- *POTTED PLANTS ARE PERMITTED IN THE SAME AREA AS FLOWER BEDS (GRAVE SIDE)
- ***NOTHING IS TO BE PLACED IN THE WALKWAY**
- *NO GLASS CONTAINERS
- *ARTIFICIAL FLOWERS ARE PERMITTED ON THE STONE SIDE ONLY, AND NO WHERE ELSE
- *WINTER WREATHS ARE PERMITTED NOVEMBER 1 TO MARCH 1
- *TREES, SHRUBS, AND BUSHES OF ANY KIND ARE NOT PERMITTED. EXISTING SHRUBS AND EVERGREENS BECOMING UNSIGHTLY WILL BE REMOVED
- *CONTAINERS FROM FUNERALS MUST BE REMOVED WITHIN 5 DAYS OF THE FUNERAL IF THE FAMILY WISHES TO KEEP THEM
- *ANYTHING PLACED ON A GRAVESITE THAT INTERFERES WITH MOWING WILL BE REMOVED
- *MONUMENTS OR MARKERS MAY BE PLACE AT THE WALWAY END OF THE GRAVE
 - *NO MARKER MAY BE PLACED AT THE FOOT END
 - *ONE MARKER PER GRAVE, WITH THE EXCEPTION OF GROUND LEVEL MILITARY MARKERS
- *LOTS MAY BE SOLD BACK TO THE TOWNSHIP AT THE ORIGINAL PURCHASE PRICE
- *VISITING HOURS ARE DAYLIGHT TO DARK
- *ONLY WOOD MULCH WILL BE PERMITTED IN THE CEMETERY
- *ONLY 6 DECORATIVE ITEMS ARE ALLOWED PER HEADSTONE
- *ALL PETS MUST BE ON A LEASH AT ALL TIMES WHILE IN THE CEMETERY
- *IF THERE IS NOT FOOTER OR HEASTONE PRESENT, ONLY ONE SMALL POTTED PLANT ALLOWED AT THE WALKWAY END OF THE GRAVE
